4. Governor Interviews:


4.1. Sanjay Arya

5. Deliberations on candidate

The Committee discussed the application and interview with Sanjay Arya and agreed that he had the knowledge, skills and experience the Board was seeking and would be an excellent addition to the Board. It was agreed that he should be recommended for appointment as a Governor to the Governing Board to serve as a member of the Curriculum and Student Matters Committee. It was also agreed that Andrea Ferguson would act as Sanjay's 'Buddy' once appointed.

The Committee agreed to invite Sanjay to attend the 3 December meeting of the Governing Board as an observer, and to attend the Governor's Christmas meal that was taking place immediately after the meeting on 3 December.
